R/86 PUBLIC OPEN SESSION (15 minutes)

There were five members of the public present.

Mr John Barrat a resident of Fishmore View, Ludlow. The LUD033 Revised SAMDev land north east of Bromfield Road

Mr Barrat raised concerns from residents of Fishmore View, a residential area adjacent to the site under consideration. He stated that the area is prone to flooding; this has been under estimated in the land survey. Alterations to the natural flow of the River Teme, may affect residents and properties upstream.

The site is unsuitable for a development of this kind as it is surrounded by a busy road, railway and a river, which floods frequently which are all potentially dangerous for children and residents. The infrastructure of the town is struggling at the present time, doctor's surgeries and schools are full and recently we have had the town bus service reduced. Access in and out of the site onto the Bromfield Road, which is already a very busy road, is unsuitable and potentially dangerous with all the school children in the area and traffic entering the town.

There is also the environmental impact on the area and effects on the wildlife to be considered.

Mr Morris informed the Members that Fishmore View play park is quite hidden away and in the past there have been problems with teenagers gathering and drinking into the early hours at the weekends. This has since quietened down because the teenagers have grown up and moved on. Residents are concerned that should a footbridge be built to link into this area it would encourage more children to visit the park, which may result in the problems re-occurring.
