The proposed extension extends sideways outside of the established building line of the property, whilst the town council accepts that the applicant owns the land for the proposed extension, the extension attached to the neighbouring property, save a small gap and flashing, will create unacceptable issues.

The neighbour property will suffer loss of amenity due to being overlooked. Specifically, an upper bedroom window will look down into the roof lights of the extension, and vice versa. There will be a loss of privacy, which will impact on the resident's use of their own property, and significant potential for invasive noise due to window / roof lights. There are significant security issues due to proposed height of the roof. Maintence of an older property will also be an issue because there will be no access to sewage pipes. The

very close proximity of the extension and the existing wall is also a potential cause of damp issues.

The property is also very close to the town walls ancient scheduled monument.

Ludlow Town Council believes that the complexities of this application should be considered by the South Planning Committee.
